### INSTRUCTIONS

**This information is submitted to your authorized service provider for filing with the Registrar pursuant to the Business Corporations Act and must conform to Section 1 of the Regulations made under the Act.**

Item 1. Enter the proposed corporate name that complies with Sections 282 and 283 of the Act.

Item 2. Enter the date the corporation was incorporated, amalgamated or continued.

Item 3. Enter the place where the corporation was incorporated, amalgamated or continued.

Item 4. Enter the complete address, including postal or zip code of the Head Office of the corporation inside or outside Alberta.

This should be the registered address of the corporation.

Item 5. Enter the principal business of the corporation. Be as specific as possible in explaining what the company does.

Item 6. Enter the complete names and addresses of all directors of the corporation including the postal or zip code.

Item 7. Indicate YES or NO in answer to the question. If YES, include complete corporate name and access number previously incorporated / registered under.

Item 8. Indicate YES or NO in answer to the question.

**The Statement of Registration form must be filed with:**

- a copy of the charter of the corporation and amendments, certified by a company official or notary public or government official
- an English translation of Charter (if applicable) certified by a company official or notary public
- Notice of Attorney for Service
- an Alberta Name Search Report (from the NUANS database) on the proposed name, dated not more than 90 days from the date the Statement of Registration is submitted to your authorized service provider.

**The following information must be included:**

- name of person authorizing (director/authorizing officer)
- title
- identification
- date

**NOTE:** Due to limited space, an appropriate attachment adhering to Section 1 of the Regulations is acceptable.
